

# **FEMALE GUIDELINES**

## **Oklahoma Red Angus Association State Sale**

OKC West Sale Facility, El Reno OK

### **1. Membership Requirements**

- a. Consignor must be a current member in good standing with OKRAA

### **2. Cattle Requirements**

#### ***a. Registered Females***

- i. Registrations must be in an R or I status by sale date
- ii. Must be a 1A or 1B with the RAAA
- iii. No Category 2 or 3 will be allowed
- iv. Must be 7 years or younger
- v. Body Condition Score (BCS) 6 or better
- vi. Free from Blemishes, pink eye, ring worm, warts etc.
- vii. Must be sound and free from hoof deformities

#### ***b. Commercial females***

- i. Must be at least 50% red angus
- ii. Must be 4 years or younger
- iii. Body Condition Score (BCS) 6 or better
- iv. Free from Blemishes, pink eye, ring worm, warts etc.
- v. Must be sound and free from hoof deformities

### **3. Health Requirements**

#### ***a. Breeding***

- i. Bred females must be pregnancy checked within 30 days of the sale

#### ***b. Identification***

- i. ALL registered females must have a legible tattoo of prefix and id in their ear.
- ii. ALL females must have an EID tag or USDA issued silver tag in their ear

#### ***c. Vet Inspection***

- i. ALL females must have a health paper with pregnancy information, lot number, Tattoo information, and EID or USDA silver tag number listed on the paper.

### **4. Expenses**

#### ***a. Entry/Catalog Fees***

- i. Registered females are \$100/head nonrefundable. This fee will be applied to sale expenses at the time of settlement.
- ii. Commercial females are \$25/head nonrefundable. This fee will be applied to sale expenses at the time of settlement.

#### ***b. Commissions***

- i. Sale expense for registered animals will be a minimum of 15%
  - 1. Example a \$3000 animal through the sale will net \$2550 to owner.
  - 2. Example a \$1500 animal through the sale will net \$1275 to owner.
- ii. Commercial cattle will be set at a 4.5% commission
- iii. No Sale Fee will be the commission multiplied by last bid through the sale ring.

## **5. Catalog**

### ***a. Photos & Footnotes***

- i. Consignors are responsible for photos and footnotes for their animals.
- ii. Only quality pictures will be put in the catalog.
- iii. Please contact a sale committee member or Sales Management for Professional Photographer options if interested.

### ***b. Catalog Advertising***

- i. Retail price is \$500 for a full page, ½ page \$300, business card \$100
- ii. Consignors will receive 50% discount for ads placed in the catalog.

## **6. Scratches / Substitutions**

### ***a. Scratches***

- i. Entry fees are nonrefundable.
- ii. Entry fee for any scratched lots will be applied to other lots entered in the sale if applicable

### ***b. Substitutions***

- i. Substitutions will be accepted with approval of the sale committee.

## **7. Disputes**

- a. All disputes are between buyer and seller.
- b. All animals are guaranteed by the seller as outlined in the Red Angus Association of America code of ethical sale practices.

The Oklahoma Red Angus Association strives to maintain quality in State Sale for the reputation of consignors and the breed.

The Oklahoma Red Angus Association and Sale committee have the responsibility to prevent any cattle from selling if they do not meet the requirements listed above.

All decisions by the Sale Committee are final.
